On October 2, 2015, you were notified that The Larson Group (Peterbilt and Larson Farm and Lawn) was terminating their direct agreement to use the Mercy network effective October 31, 2015. At that time, it was our understanding that they would be going to a plan through Anthem Blue Cross Blue Shield that would be out-of-network in the Springfield and Joplin area effective November 1, 2015.

However, upon further investigation, we have discovered that they have enrolled in the Blue Access Choice S network. This is a new product in Southwest Missouri that includes all of our Southwest Missouri hospitals and clinics as in-network providers, including Springfield and Joplin. The plan also includes BlueCard privileges, so that providers in Arkansas and Kansas will be in network based upon your participation with the local Blue Cross Blue Shield plan.
